



Limited Express Warranty - General

Except as otherwise set forth in VSG's Terms and Conditions of Sale, VSG warrants that all products identified below ("Products"), when used in the manner and under the conditions for which they were designed, will be free from defects in materials and workmanship for the applicable warranty periods set forth below. Subject to the terms and conditions herein, if within the applicable warranty period and in VSG's sole discretion such Products shall be proved to VSG's satisfaction upon inspection and in VSG's sole discretion to be non-conforming, VSG will either, in its sole discretion, repair or replace those Products returned to the factory. VSG also will pay for reasonable costs of transportation and/or labor for replacement of such Products during the applicable warranty period. Parts replaced under warranty will be warranted for the remainder of the applicable warranty period of the original Product.

All Products (including all replacement parts and accessories) are warranted to the original owner only, as set forth herein, and are not transferable.

Important: The limited express warranty period begins once the Product is invoiced to an authorized Distributor/ Purchaser/ Account. This date can be adjusted by submitting the Warranty Activation Form indicating the installation date or by proof of purchase. The warranty period can only be adjusted for a period of 6 months after the original ship date unless approved in writing by VSG Customer Service.

Limitation of Warranty: This limited express warranty shall not apply unless the Product is installed, operated, used and maintained in accordance with specifications as set forth in installation, operation and maintenance instructions. This limited express warranty does not apply to normal maintenance or adjustments, including routine calibrations, remedies for routine maintenance, damage or malfunction caused by improper handling, installation, abuse, misuse, negligence, carelessness of operation, or normal wear and tear. In addition, this limited express warranty does not apply to equipment when unauthorized repairs or alterations have been attempted or made to the Product.

Limitation of Liability - General

REMEDIES: THE DAMAGE LIMITATIONS PROVIDED IN VSG's TERMS AND CONDITIONS OF SALE AND THE REMEDIES STATED HEREIN SHALL BE EXCLUSIVE AND SHALL BE BUYER'S SOLE AND EXCLUSIVE REMEDY (EXCEPT AS OTHERWISE EXPRESSLY PROVIDED HEREIN). ALL REMEDIES MUST BE COMPLETED UTILIZING A VSG AUTHORIZED INSTALLER.

DISCLAIMER OF ALL OTHER WARRANTIES: EXCEPT AS SET FORTH IN VSG'S LIMITED EXPRESS WARRANTY APPLICABLE TO THE PRODUCTS, VSG EXPRESSLY DISCLAIMS AND MAKES NO OTHER WARRANTIES, WHETHER EXPRESS, IMPLIED OR STATUTORY, INCLUDING, WITHOUT LIMITATION, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. BUYER ACKNOWLEDGES THAT IT IS NOT RELYING UPON VSG'S SKILL OR JUDGMENT TO SELECT OR FURNISH GOODS SUITABLE FOR ANY PARTICULAR PURPOSE OR UPON ANY AFFIRMATIONS OF FACT OR PROMISES OF VSG WHICH EXTEND BEYOND SPECIFICATIONS PUBLISHED BY VSG. BEFORE USING OR PERMITTING THE USE OF THE PRODUCTS, BUYER SHALL DETERMINE THE SUITABILITY OF THE PRODUCTS FOR THE INTENDED USE AND UNDER BUYER'S OPERATING CONDITIONS, AND BUYER SHALL ASSUME ALL RISK AND LIABILITY WHATSOEVER IN CONNECTION THEREWITH. IN THAT REGARD, AND EXCEPT AS OTHERWISE EXPRESSLY PROVIDED HEREIN, BUYER AGREES AND ACKNOWLEDGES THAT IT IS ACCEPTING ANY GOODS, SERVICES AND / OR PRODUCTS HEREUNDER ON AN "AS-IS" AND "WITH ALL FAULTS" BASIS. FURTHERMORE, BUYER HEREBY EXPRESSLY AGREES AND ACKNOWLEDGES THAT VSG SHALL HAVE NO LIABILITY OF ANY NATURE HEREUNDER BEYOND REPLACEMENT OR REPAIR OF ANY DEFECTIVE PRODUCT, OR PART, INDIVIDUAL COMPONENT OR SPOOL THEREOF, EXCEPT AS EXPRESSLY SET FORTH HEREIN.

INCIDENTAL AND CONSEQUENTIAL DAMAGES: TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, VSG'S AGGREGATE LIABILITY WITH RESPECT TO THE PRODUCTS PROVIDED HEREUNDER SHALL BE LIMITED TO THE AMOUNT RECEIVED BY VSG FOR THE PRODUCTS GIVING RISE TO ANY CLAIM HEREUNDER. TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, VSG SHALL NOT BE SUBJECT TO, AND BUYER EXPRESSLY DISCLAIMS AND WAIVES ANY CLAIM OR INTEREST IN OR TO, ANY AND ALL INDIRECT, SPECIAL, EXEMPLARY, PUNITIVE, CONSEQUENTIAL, INCIDENTAL AND CONTINGENT DAMAGES WHATSOEVER RESULTING FROM VSG'S PERFORMANCE OR FAILURE TO PERFORM UNDER THE CONTRACT OR THE FURNISHING, PERFORMANCE OR USE OF ANY PRODUCTS SOLD PURSUANT HERETO, WHETHER DUE TO BREACH OF CONTRACT, BREACH OF WARRANTY, STRICT LIABILITY, PRODUCT LIABILITY, THE NEGLIGENCE OF VSG OR OTHERWISE AND WHETHER OR NOT SUCH LOSS WAS FORESEEABLE OR WHETHER BUYER HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

SPECIFICALLY EXCLUDED DAMAGES: WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, AND TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, VSG SPECIFICALLY DISCLAIMS AND BUYER WAIVES ANY LIABILITY OR CLAIM FOR PROPERTY OR PERSONAL INJURY DAMAGES, PENALTIES, DAMAGES FOR LOST PROFITS OR REVENUES, LOSS OF USE OF PRODUCTS OR ANY ASSOCIATED EQUIPMENT, COST OF CAPITAL, COST OF SUBSTITUTE PRODUCTS, FACILITIES OR SERVICES, DOWN TIME, SHUT DOWN OR SLOW DOWN COSTS OR FOR ANY OTHER TYPES OF ECONOMIC LOSS AND FOR CLAIMS OF BUYER'S CUSTOMERS OR ANY THIRD PARTY FOR ANY SUCH DAMAGES.

NOTE: Some states do not allow the exclusion or limitation of incidental, consequential or punitive damages, so the above limitation or exclusion may not apply to Buyer. This warranty gives Buyer specific legal rights, and Buyer may have other rights that vary from state to state. The portions of this limited warranty and limitation of liability shall be considered severable and all portions which are not disallowed by applicable law shall remain in full force and effect.

To activate the first year parts and labor warranty on Shockwave™, SmartLift®, Dual Control, One Touch Control, RLP77 series, VREX, EFX, Parallelogram, HDC and MOD Products, the installation shall be done by a Rotary Authorized Installer (RAI) and the product installation registered with the factory.

EXCEPTIONS:

BATTERIES (warrantied by battery manufacturer)

PAINT DEFECTS DUE TO EXTERNAL INFLUENCES: Accidental damage, climatic, thermal, chemical or industrial pollution, insufficient care or maintenance

WEAR ITEMS: Cables, Sheaves, Adapter Pads, Radius Gages, Rear Steers, Lights, etc. Except failures resulting from poor workmanship or material defects

AC Units: Oxygen Sensors have a 1 year functional parts warranty.

Any optional extended functional parts warranties must be purchased at the point of sale or within the first year of installation of the Product.

Notwithstanding anything else stated in the general warranty terms, transportation and labor costs associated with repair or replacement of Chief replacement parts are not included.
